Post Summary

Paediatric Dentistry is an age-defined specialty that provides both primary and comprehensive preventive and therapeutic oral health care for infants and children through adolescence, including those with special healthcare needs. The speciality encompasses all aspects of dentistry, recognising that children are unique in their stages of development, oral disease, and oral health treatment needs. The paediatric dentist is recognised as a primary care provider as well as a resource for specialty referral for all children. Paediatric Dentistry also includes training for children and adolescents with disabilities, (in Ireland, the specialty of Special Care Dentistry caters for adults with disabilities and marginalised groups). Paediatric Dentistry is taught as a module in 4th and 5th Year Dental Science with a laboratory and clinical component. The Paediatric Dentistry Specialty Training Programme prepares the student both didactically and clinically to manage the child patient in a variety of settings at specialist level (1-2 trainees/year). The training includes core academic courses, specialty training in paediatric dentistry and a research dissertation leading to award of the D.Ch.Dent. Postgraduate clinical experience is provided under consultant/specialist supervision in the DDUH and in two children's hospitals. Further education is provided to general dental practitioners in Paediatric Dentistry as a module within a MSc course in general dental practice and is delivered within the Dental School. Research is also supported with various themes including traumatic dental injuries and children with special dental needs. The programmes and clinical service are organised by one full time consultant and one part time specialist, with clinical instruction by part-time consultants (2), specialists (3) and general dentists (4).

Standard Duties and Responsibilities of the Post

The role of the Assistant Professor in Paediatric Dentistry includes but is not limited to the following duties. It is recognised that competence to execute these duties will depend on whether the successful candidate enters with a specialty qualification or a research degree.

- Assisting with the delivery of the Paediatric Dentistry course, including the delivery of lectures and problem-based learning, and providing clinical supervision for dental science as well as Paediatric Dentistry education within auxiliary programmes, as determined by the Head of Division.
- Taking responsibility, in association with the Consultant and Specialist in Paediatric Dentistry, for course documentation, teaching material and course-related staff management. Development of additional educational programmes for continuing professional development of dental professionals.
- Assisting with the assessment of laboratory-based competences and clinical competences in Paediatric Dentistry.
- Supporting the Consultant/Specialist in Paediatric Dentistry in providing clinical services to patients at the DDUH or other Hospitals by;
 - a) Assessing primary and secondary referral patients.
 - b) Providing specialist Paediatric Dentistry services to patients.
- Participation in interdisciplinary and multidisciplinary clinics as part of professional development towards senior clinical position.
- Actively engaging in research to complete a PhD in Paediatric Dentistry within the School of Dental Science/Trinity (if not already holding a relevant PhD)

OR

- Developing research themes and undertaking research as part of his/her D.Ch.Dent course in Paediatric Dentistry (if already holding a Ph.D.).
- Providing support to research internally and externally by attending and presenting at relevant meetings (nationally and internationally).
- Supervising student paediatric dentistry sessions, treatment plans and competences; acting as a clinical academic advisor and/or undergraduate portfolio supervisor, as requested by the Head of Division.
- Assisting with the setting of examination questions, marking of manuscripts, active
 participation in clinical examination of Dental Science and Postgraduate programmes
 and the provision of support for other courses as required.
- Publication of original material (reviews, case studies, research results).
- Attend the Divisional meetings and all other meetings as required.

Qualifications

Each candidate must:

 Have completed Specialist Training in the area of Paediatric Dentistry and wish to undertake a research doctorate (Ph.D.) over five years, with post specialist training opportunities.

OR

- Have completed a research doctorate (Ph.D.) and wish to undertake Specialist Training through completion of a D.Ch.Dent (Paediatric Dentistry) over five years with post specialist training opportunities.
- Have demonstrated a commitment to dental research.
- Be registered or eligible for full registration with the Dental Council of Ireland within 6 months of being offered the position.

Objectives

Each candidate must achieve the following during the 5 year fixed term contract:

- Complete registration with the Dental Council of Ireland within 6 months.
- Complete PhD (if applicable) submitted and defended successfully.
- Complete specialist level training evidenced by D. Ch. Dent or equivalent, if entered with specialist level qualification.
- Demonstrate ability to perform duties at Consultant level
- Publish 1-3 articles in peer reviewed Journals within 5 years.
- Present at a National Conference within the first 2 years and at an International Conference within 3 years.
- Complete the TCD Certificate in Academic Practice Developing Creative Teaching And Learning Approaches In Your Discipline
- Demonstrate competent clinical supervision of year 4 and 5 Undergraduate students in Paediatric Lab and Clinics.
- Demonstrate competent clinical supervision of Postgraduate students.
- Undertake co-supervision of at least 2 student dissertations in years 1 and 2 and at least 2 student projects in years 4 and 5.
- Demonstrate to develop and execute teaching modules within existing programme

- Have excellent interpersonal and communication skills.
- Be able to identify potential difficulties and formulate solutions.
- Be personally motivated with the ability to empower and motivate others.
- Have demonstrable adaptability to rapid changes taking place in the Hospital, educational and health services in general.

- Have proven organisational and administrative skills.
- Be fully competent in MS Office, in particular Word, Excel, Outlook, Internet and other relevant packages.

GARDA CLEARANCE:

Police vetting will be sought in respect of individuals who come under consideration for a post.

PLEASE NOTE: Applicants will be required to complete and return a Garda vetting form should they come under consideration for appointment. In some cases they may be requested to complete the form on the day of interview. This form will be forwarded to An Garda Síochána (Irish Police) for security checks on all Irish addresses at which they have resided. An Garda Síochána will make enquiries with the Police Service of Northern Ireland with respect to addresses in Northern Ireland. If an applicant is not successful in obtaining the post for whatever reason, this information will be destroyed. If an applicant, therefore, subsequently comes under consideration for another position, they will be required to supply this information again.

While applicants must complete information in relation to all addresses at which they have resided, the vetting is only done on addresses on the island of Ireland.

If an applicant has resided / studied in countries outside of Ireland for a period of 6 months or more, it is mandatory for them to furnish a Police Criminal Records Check/ Police Certificate from those countries stating that they have no convictions recorded against them while residing there. Applicants will need to provide a separate Police Criminal Records Check/ Police Certificate for each country in which they have resided. The Police Criminal Records Check/ Police Certificate must be dated after the date the applicant left the relevant country. Applicants should provide documentation in the English and/or Irish language. Translations must be provided by a registered translation company/institute in the Republic of Ireland; all costs will be borne by the applicant. Only original version documents will be accepted.







The Selection Process in Trinity

The Selection Committee (Interview Panel) may include members of the Academic and Administrative community together with External Assessor(s) who are expert in the area. Applications will be acknowledged by email. If you do not receive confirmation of receipt within 1 day of submitting your application online, please contact the named Recruitment Partner on the job specification immediately and prior to the closing date/time.

Given the degree of co-ordination and planning to have a Selection Committee available on the specified date, the University regrets that it may not be in a position to offer alternate selection dates. Where applicants are unavailable, reserves may be drawn from a shortlist. Outcomes of interviews are notified in writing to applicants and are issued no later than 5 working days following the selection day.

In some instances the Selection Committee may avail of telephone or video conferencing. The University's selection methods may consist of any or all of the following: Interviews, Presentations, Psychometric Testing, References and Situational Exercises.

It is the policy of the University to conduct pre-employment medical screening/full preemployment medicals. Information supplied by applicants in their application (Cover Letter and CV) will be used to shortlist for interview.

Applications from non-EEA citizens are welcomed.
